SUBJECT: Eastern Caribbean Cruise

Are you interested in an Eastern Caribbean Cruise?

We have two options:

Norwegian Cruise Line Ships

1. The cruise would be for seven (7) days – January 3 through January 10, **2009**
2. The Cost would be as follows per person:
 - a. For an inside cabin - \$790.44
 - b. For an oceanview cabin - \$940.88
 - c. For a balcony cabin - \$1,160.88
3. The ship would leave out of Miami, Florida and stop at Samana Dominican Republic; St Thomas - U.S. Virgin Islands; Tortola - British Virgin Islands; and Great Stirrup Cay Bahamas.
4. If you are interested, the travel agent has to have a \$50 per person deposit as soon as possible.

Royal Caribbean Cruise Line – “Freedom of the Seas”

1. The cruise would be for seven (7) days – January 11 through January 18, 2009
2. The cost would be as follows per person;
 - a. For an inside cabin - \$998
 - b. For an ocean view cabin - \$1,264
 - c. For a balcony cabin - \$1,284
 - d. For the Promenade stateroom - \$1,054
3. The ship would leave out of Miami and stop at San Juan, Puerto Rico; Charlotte Amalie, St. Thomas; and Philipsburg, St. Maarten.
4. If you are interested, the travel agent needs a \$500 deposit by May 1, 2008.

EXTRAS:

1. The cost for air is not included because at this time, the price is too high so we are going to wait for a few months and hope the price goes down.
2. If you have flown with the EAA Chapter 597 before, we work it out so that you can make monthly payments.
3. Passports are needed for both of the cruises.
4. **REMEMBER, ALL THE DETAILS ARE TENTATIVE AND WILL BE PERMANENT CLOSER TO THE TIME OF DEPARTURE.**
